

TERMS AND CONDITIONS FOR QUINNY CAMPAIGN

This campaign is an initiative of Dorel Netherlands, a trade name of Maxi Miliaan BV, Korendijk 5, NL-5704 RD Helmond, The Netherlands (hereinafter "**Dorel**"). By taking part in this campaign, the participant accepts these general terms and conditions.

Article 1 General

- 1.1 This campaign is organised by Dorel and its purpose is to promote Quinny products.
- 1.2 The campaign is free to enter.
- 1.3 Details of the campaign will be published and accessible on the website www.longboardstroller.quinny.com. The terms and conditions of the campaign, any specific terms and conditions which will apply for any specific country and other information on the campaign will also be provided on the website.
- 1.4 In these terms and conditions, the words listed below will have the following meanings:
 - 'campaign': the "Quinny longboardstroller ride with your kid" campaign to promote the Quinny longboardstroller;
 - "participant": any person who has registered to take part in the campaign via the website;
 - "website": the website www.longboardstroller.quinny.com.
- 1.5 No purchase of any product is necessary.

Article 2 Campaign

- 2.1 The campaign period runs for 3 weeks starting on Tuesday the 7th of July 2015 and ending on Monday 27th of July 2015.
- 2.2 Participants can take part in the campaign by registering on the website, accepting these terms and conditions nominating their favourite spot to go for a ride with their kid on the Quinny longboardstroller in accordance with these terms and conditions.
- 2.3 The participants who follow these rules during the campaign and leave their data on the website in accordance with these terms and conditions, will qualify to receive a prize throughout the campaign (see Article 4).

Article 3 Participation

- 3.1 All participants will be bound by the provisions of these terms and conditions and consent to these terms and conditions by taking part in the campaign.
- 3.2 The participant:
 - guarantees that the information which he/she has provided with regard to this campaign is correct, up to date and complete;
 - guarantees that the personal information that he/she has provided with regard to this campaign was entered by himself/herself;
 - must be at least 18 years old or above;
 - will by participating permit Dorel to use quotes and other works which he/she has produced and posted on the website with regard to this campaign for promotional purposes without further notice, without claiming compensation of any kind or requiring that his/her name be mentioned;
 - will by participating grant Dorel permission to use his/her name, likeness, voice, biographical information and all other information participant has provided with regard to this campaign for promotional purposes in all media without further notice and without claiming compensation of any kind;
 - agrees to participate in any publicity or other promotional activities which Dorel may reasonably require in connection with the promotion of the campaign;

- guarantees that he/she has actually consented to the general terms and conditions. It is not permitted to have other persons do this on the participant's behalf.
 - will by participating in the campaign grant Dorel permission to send him/her information as part of its marketing activities. Each communication from Dorel will contain an option enabling the participant to withdraw his/her permission permanently.

- 3.4 Dorel employees, the immediate families of employees of Dorel or any affiliates or subsidiary companies, representatives or agents of Dorel and anyone who is in any way involved, directly or indirectly, in the development and implementation of the campaign are precluded from taking part in this campaign. Entries submitted by the aforementioned persons will be invalid.
- 3.5 Only one entry per e-mail address will be accepted.

Article 4 Prizes
